

## **Trinity Parkway Advances**

*SDEIS available for public review, public hearing scheduled*

**Dallas, Texas** – A major milestone has recently been reached on the Trinity Parkway project as the Supplemental Draft Environmental Impact Statement and Draft Section 4(f) Evaluation (SDEIS) for the Trinity Parkway is now available for public review. The public is also invited to attend a public hearing on the project conducted by the North Texas Tollway Authority (NTTA), in cooperation with the Texas Department of Transportation (TxDOT), scheduled for May 5, 2009, at 7:00 p.m. at the Dallas Convention Center Arena.

The SDEIS discusses the potential impacts the Trinity Parkway project could have on various social, economic and environmental elements. The document was prepared to provide new or additional information and data analysis performed since the Draft Environmental Impact Statement was published in February 2005. A no-build alternative (Alternative 1) and eight build alternatives (Alternatives 2A, 2B, 3A, 3B, 3C, 4A, 4B and 5) are evaluated in the SDEIS and will be presented at the public hearing. Each build alternative is approximately nine miles long and begins at IH 35E/State Highway (SH) 183 and ends at U.S. Highway 175/SH 310.

The hearing on the proposed Trinity Parkway project will be at 7 p.m. Tuesday, May 5, 2009, at the Dallas Convention Center Arena, 650 S. Griffin Street, Dallas, 75202. The purpose of the public hearing is to inform and solicit comments from the public on the conceptual schematics for proposed project alternatives as well as the information contained in the SDEIS. The formal public hearing presentation will begin promptly at 7 p.m., followed by a public comment period. Please note that during the public comment period, responses to comments will not be made because of time constraints and in order to allow everyone an opportunity to speak.

Prior to the hearing, from 4 p.m. to 7 p.m., NTTA and TxDOT staff will be available at an open house to answer questions about the project. Conceptual schematic drawings, the SDEIS, and other project-related information will be available for review and displayed at the open house.

#### ***About the NTTA***

The North Texas Tollway Authority, a political subdivision of the state of Texas, is authorized to acquire, construct, maintain, repair and operate turnpike projects in the North Texas region. The nine-member governing board is comprised of Chairman Paul N. Wageman; Vice Chairman Victor Vandergriff; and Directors Kenneth Barr, Gary Base, Bob Day, David Denison, Michael Nowels, Bob Shepard and Alan E. Sims.

The NTTA serves Collin, Dallas, Denton and Tarrant counties and is responsible for the NTTA System, consisting of the Dallas North Tollway, President George Bush Turnpike, Sam Rayburn Tollway, Addison Airport Toll Tunnel, Lewisville Lake Toll Bridge and the Mountain Creek Lake Bridge. The NTTA is able to raise capital for construction projects through the issuance of turnpike revenue bonds. NTTA toll projects are not a part of the state highway system and receive no direct tax funding. Tolls are collected to repay debt and to operate and maintain the roadways.
