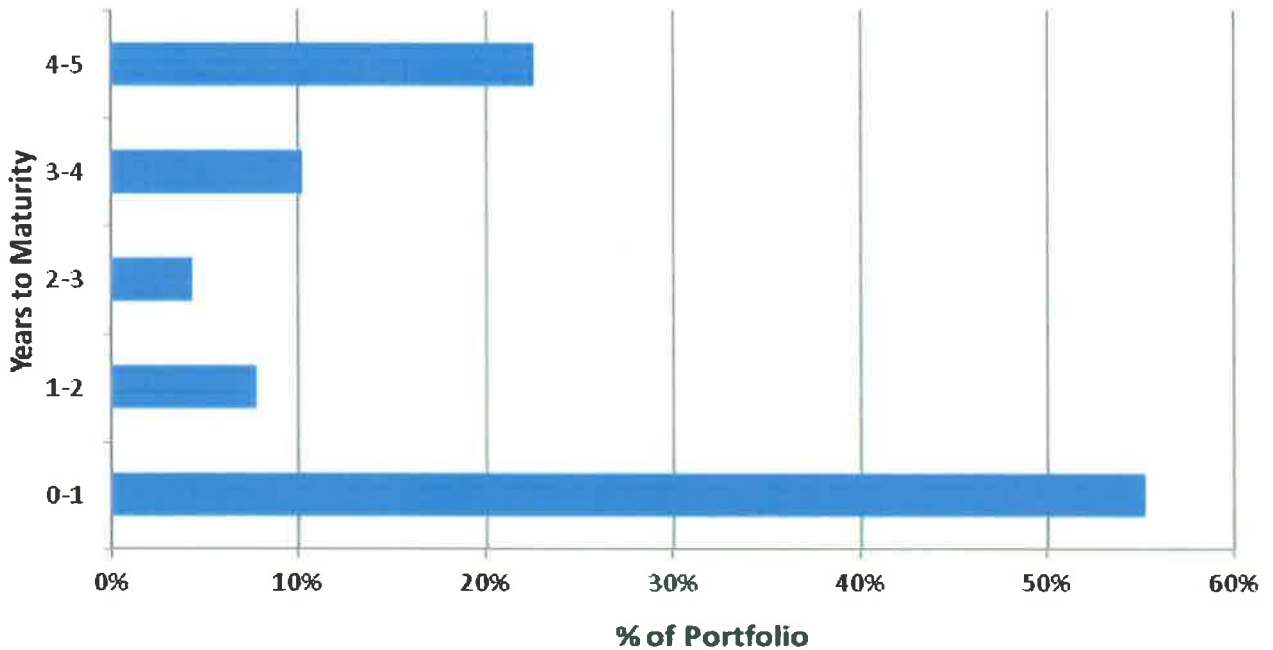

### Portfolio Maturity Schedule a/o 6/30/2013

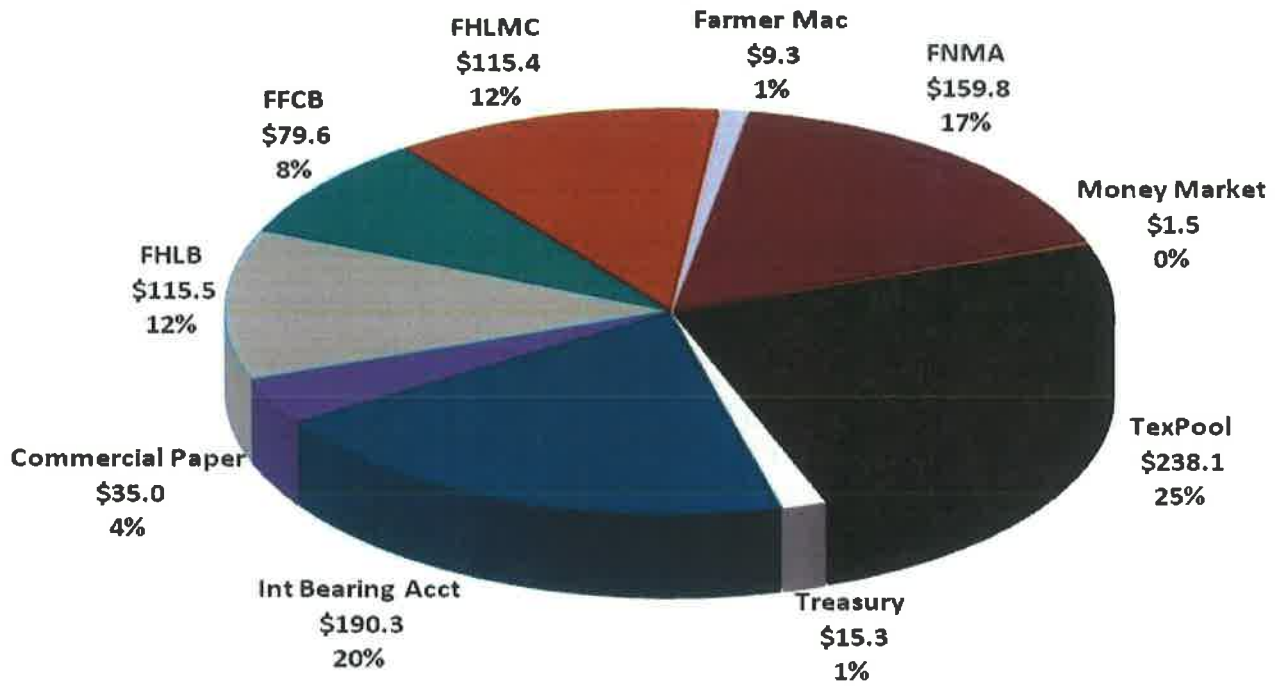


### Portfolio Composition

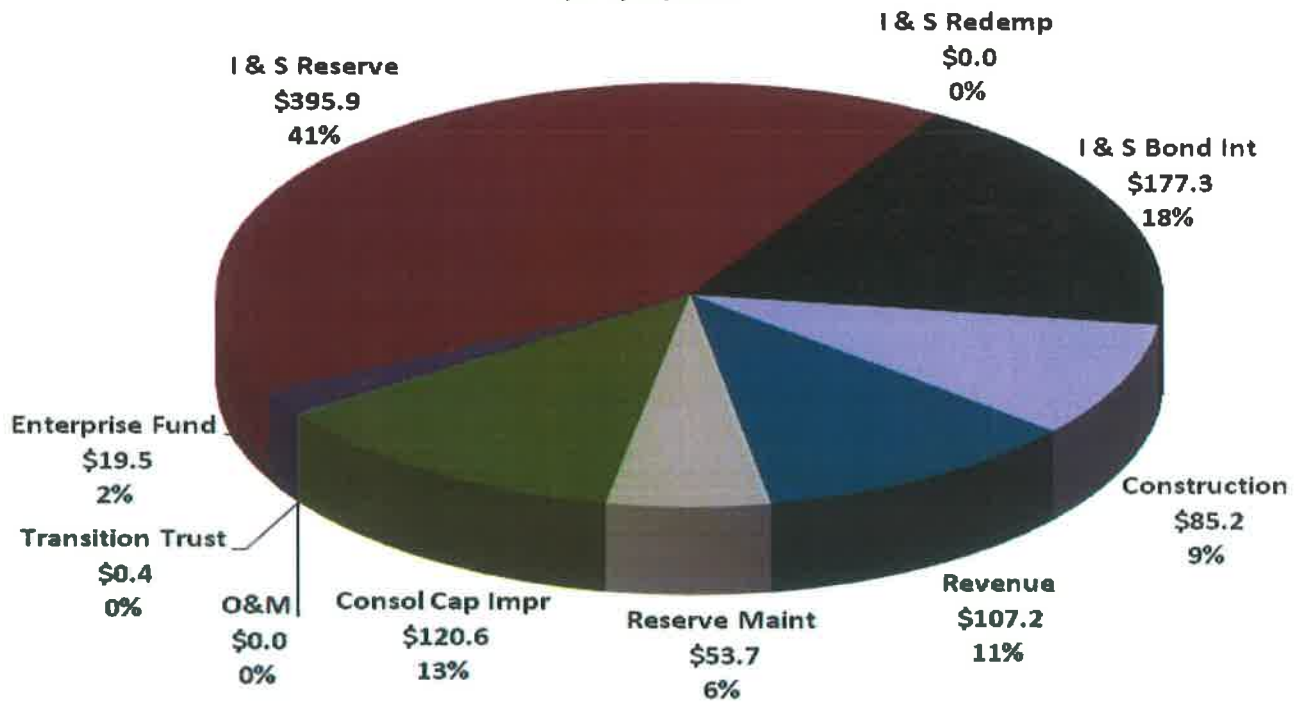


### Portfolio Composition

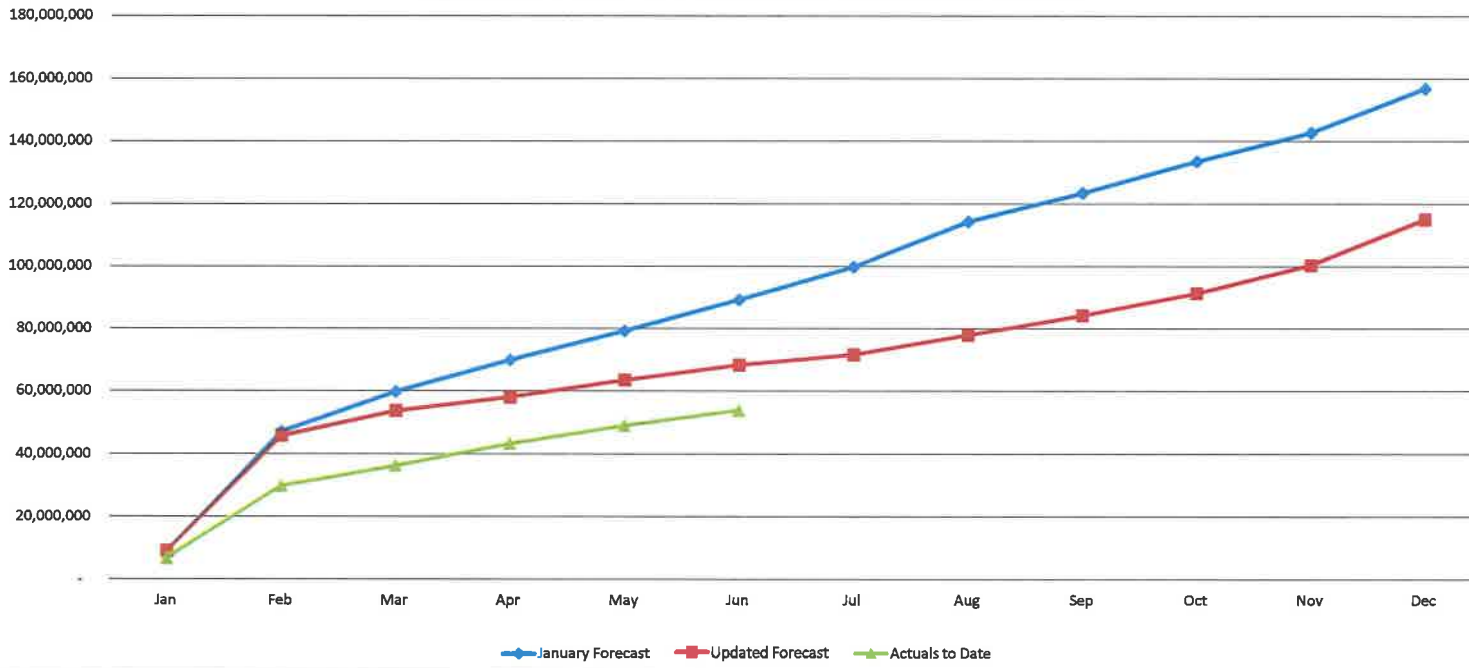
