INTERAGENCY COOPERATION CONTRACT

COUNTY OF TRAVIS

THIS CONTRACT AND AGREEMENT is entered into by and between the State agencies shown below as Contracting Parties, pursuant to the authority granted and in compliance with the provisions of "The Interagency Cooperation Act" Article 4413 (32) V.C.S.

I. CONTRACTING PARTIES:

The Receiving Agency: Texas Turnpike Authority

The Performing Agency: Texas Department of Transportation

II. STATEMENT OF SERVICES TO BE PERFORMED: (See Instructions on Page 4)

The Performing Agency agrees to furnish various quantities of roadway maintenance items which may be requested by the Receiving Agency during the contract period. The Performing Agency will provide only such material which are normally stocked in the regional warehouses of the Performing Agency. The quantities furnished of any requested materials will be subject to their availability at the time of request. The Receiving Agency will be responsible for arranging pick up/delivery of all goods and materials.

III. BASES FOR CALCULATING REIMBURSABLE COSTS: (See Instructions on Page 4)

The Receiving Agency will reimburse the Performing Agency for the actual cost at the time of issue for all goods and materials received, plus any freight costs. The individual cost(s) of specific item(s) may vary during the contract period.

IV. CONTRACT AMOUNT:

The total amount of this Contract shall not exceed: \$50,000.00 (Fifty Thousand Dollars)

V. PAYMENT FOR SERVICES: (See Instructions on Page 4)

Receiving Agency shall pay for services received from appropriation items or accounts of the Receiving Agency from which like expenses would normally be paid, based upon vouchers drawn by the Receiving Agency payable to Performing Agency.

Payments for service performed shall be billed: within 10 days after furnishing materials.
(Weekly, monthly lump sum, etc.)

Payments received by the Performing Agency shall be credited to its current appropriation item(s) or account(s) from which the expenses of that character were originally made.

VI. TERM OF CONTRACT:

This Contract is to begin September 10, 1992, and shall terminate August 31, 1993 (Term of Contract cannot transcend the biennium.)

THE UNDERSIGNED CONTRACTING PARTIES do hereby certify that, (1) the services specified above are necessary and essential for activities that are properly within the statutory functions and programs of the effected agencies of State Government, (2) the proposed arrangements serve the interest of efficient and economical administration of the State Government, and (3) the services, supplies or materials contracted for are not required by Section 21 of Article 16 of the Constitution of Texas to be supplied under contract given to the lowest responsible bidder.

RECEIVING AGENCY further certifies that it has the authority to contract for the above services by authority granted in Chapter 411.013, Local Government Code, VTCA 1987 (Statute, Constitution, Special Provision of Appropriation Bill)

PERFORMING AGENCY further certifies that it has authority to perform the services contracted for by authority granted in Article 6663, V.A.C.S. (Statute, Constitution, Special Provision of Appropriation Bill)

SUBJECT TO THE APPROVAL of the State Purchasing and General Services Commission, the undersigned parties bind themselves to the faithful performance of this contract. It is mutually understood that this Contract shall not become effective until approved by the State Purchasing and General Services Commission, and that such approval must be obtained prior to the beginning date of the Contract.
