The NTTA is providing the following change to on Section 16 Part (a) of the contract for RFQ 03583-SH161-04-PS-PM.

- a) NTTA Indemnified: Consultant will indemnify and hold harmless NTTA and its officers, directors, employees, agents, consultants and representatives (collectively "the indemnitees") from any claims, costs, or liabilities arising from an act of negligence, intentional tort, intellectual property infringement, or failure to pay a subcontractor or supplier, owed to or claimed by any persons whomsoever, to the extent arising from consultant's performance of the services, or consultant's failure to perform such services whether such claim or liability is based in tort or strict liability or caused by an employee, agent, contractor, consultants or representative consultant against the indemnitees in such

event, Consultant also will indemnify and hold harmless the indemnitees from any and all expenses including reasonable attorneys' fees, incurred by any indemnitees in litigating or otherwise responding to said claim or liabilities, paying the same as they accrue. In the event that any of the indemnitees is/are found to be partially at fault, Consultant will, nevertheless, indemnify the indemnitees from and against the expenses claims, or liabilities relating to the percentage of fault attributable to Consultant, its employees, agents, contractors, consultants or representatives of to the conduct. The provisions of this section will survive the termination of this agreement for any reason, including pursuant to any termination right provided for or allowed hereunder.
